Each of us personally and unconditionally guarantees to pay on demand all sums due or that become due to Black's Tire Service, Inc. from the Applicant and all losses, costs, attorney's fees, or sums due or that become due to Black's Tire Service, Inc. from the Applicant and all losses, costs, attorney's fees, or expenses which may be incurred by Black's Tire Service, Inc. by reason of the Applicant's default.
